BL advising that both she, and AJ had attended the public engagement meeting regarding Tywyn Hospital. Closure of Dyfi Ward was discussed and there were 18 options put forward with only one fitting the engineered criteria which related to the existing budget. There is a follow up meeting planned. BL mentioned that minor injuries and dressings clinic is now utilising the ward space. A final decision is expected by the end of 2025.

BL mentioned that she had been invited to a Tywyn Community Transport Meeting but was unable to go. She had been informed that this was a very new project and would focus on volunteers setting up a community transport scheme to assist people getting to hospital appointments. Asked Clerk to look out for an email relating to it which should be received shortly.
